### **Min 151 / Oct/ 08 Transportation and Highway Issues**

1. Temporary closure of Market Street from 1700hours on Friday 21<sup>st</sup> November to 1800 hours on Saturday 22<sup>nd</sup> November for the Festival of the Senses.
2. The Technical Officer reported that CCC had replaced a period light fitting with a modern fitting onto the wall of the Pet shop in Carmarthen Street. The Clerk was to write to CCC to ask for the replacement light fitting to be changed to one in keeping with a conservation area.

### **Min 153 / Oct /08 The Technical Officer Report**

Mr Davies had asked the Hurleys company to provide a costing for carrying out remedial work to the boiler at the Shire Hall . This is due to the Lorne Stewart company not responding to the order ( DD 190) sent to them on the 14<sup>th</sup> July.

Work was due to start on the block flooring at the Shire Hall by Morris, Prospect Builders. CCC Footpaths Officer Kevin Thomas informed Mr Davies that their rangers would take over the maintenance of the Town's footpaths from next April. The committee would insist that their work would be up to the standard of the current maintenance carried out by Mr Hugh Gwynne. The Committee agreed with Mr Davies's suggestion to switch off the Church light at 11pm rather than 12 midnight to conserve energy.

### **Min 154 / Oct / 08 The Shire Hall**

The Technical Officer presented a report on details of the responsibilities of the leaseholder at Shire Hall with regard to maintenance with a clear demarcation with the responsibilities of the Council. It was agreed that a subgroup would be set up to discuss the report with Cambria. The subgroup would consist of Cllr Colin Jenkins, Cllr Ieuan Gwyn, The Technical Officer , the Clerk, together with the Chair of the Finance Committee, Cllr Ros Bellamy.

### **Min 155 / Oct/ 08 Correspondence**

1. CCC Assistant Ground Maintenance Manager, Gerwyn Thomas – reply to the Mayor's letter of thanks for the work carried out at Penlan Park to remove damaged trees and shrubs. Mr Thomas suggested that the Council consider applying for grant to complete the work. The Civic Trust Award could then be applied for.
2. WAG/CCC report on Clean Environments. It was decided to ask Cllr Dawn Wallace to examine the report.
3. Cllr Roy Davies – letter of concern at the lack of communication from CCC regarding joint consultations on future developments in the Town. Cllr Chris Parish was to attend the Tywi Network meeting at Gwynfe to raise Cllr Davies's concerns.
